

Girl Scout and Adult Responsibility Agreement

Guardians please read, complete and sign this form for each Girl Scout participating in the 2021 Fall Product Program. Products may not be picked up and money may not be collected from customers until this form is on file with your Troop Product Manager.

Parent/guardian support is critical to your Girl Scout's success, we ask your help in agreeing to the following:

- I agree to only sell products with my Girl Scout via the specified channels and within the program timeframes as outlined below:
 - * **9/24-10/10:** Girl Scouts take paper orders and launch M2 storefront—no money collected at this time, except Care to Share donations or online payments made through M2 storefront
 - * **10/10:** All orders collected via paper order card entered online in M2 system
 - * **10/10-10/20:** Online orders for magazines and direct ship nuts/candy continue
 - * **10/27-11/14:** Delivery of product and collection of money—product may be delivered as soon as received
 - * **11/14:** 100% of money from orders collected via paper order card due to Troop Product Manager
- I agree that products will only be sold at the price indicated on the order card or on the M2 storefront.
- I agree to accept online payment for products *only* through the M2 Media virtual storefront program.
- I agree that 100% of donation funds accepted will be credited as Care to Share donation items.
- I agree to get signed receipts for all product and money exchanged with the Troop Product Manager.
- I understand that unsold product cannot be returned to the troop or council. Once signed for, all products are the financial responsibility of the adult signing the receipt.
- I will ensure my Girl Scout is properly supervised by an adult while taking orders (in person, as health directives allow, and/or online) and while delivering products.
- I agree to turn in 100% of money collected to the Troop Product Manager.
- I understand that I will be charged a \$40 late fee if full payment is not made by the deadline above. If collection action is needed, I agree to pay reasonable attorney fees and costs of collection.
- I agree to visit www.GirlScoutsWW.org/COVID prior to my Girl Scout's participation in the 2021 Fall Product Program and ensure we follow all *COVID-19 Member Safety Guidelines* in place during program participation.
