

# Girl Scouts of Western Washington

### 2026 National Council Session Delegates and Alternates

Every three years Girl Scouts of the USA (GSUSA) holds a National Council Session (often called convention) that brings together Girl Scouts from across the US to discuss, debate, and vote on issues important to the Girl Scout Movement and elect national leaders for the next triennium. Girl Scouts of Western Washington (GSWW) elects delegates from the membership body to represent our council at this national council session. GSWW is committed to ensuring youth voices at NCS and approximately half of our delegation is traditionally youth members. The July 2026 NCS is slated to be held in Washington, D.C. The following delegates have been chosen by a committee made up of members of the Board Nominating and Governance Committee as well as past NCS Delegates. This is a three-year term during which time delegates are expected to communicate with GSWW members and volunteers for their input and ideas regarding items up for review or vote at the National Council Session.

Based on membership numbers, GSWW has 12 delegate slots at the 2026 session. Two are filled by the CEO and Board President/Chair, the remainder by members of GSWW's membership body keeping in mind the need for both youth and adult representation. Below is the slate of nominees for the 12 delegates and three alternates.


# **Youth Delegates**
